In 2023 generous donors contributed \$50,000 toward the purchase of new inpatient beds. Patients and staff are now experiencing the benefits of the state-of-the-art design, featuring innovative technology for enhanced patient and caregiver safety and comfort, including:

- Adjustable height levels for all acuity levels
- Advanced fall prevention technologies with adaptive bed alarms
- IsoTour gel mattress providing extra patient comfort and prevention of pressure injuries

Future plans for Madison Health include building modern, private inpatient rooms, to elevate patient-centered care. Once completed, these beds will make the transition to our new rooms.

Second CT Scanner Essential to Meet Critical Healthcare Needs

Madison Health continues to prioritize bringing more medical specialists and services to the community. Increasing this access to care for our patients makes it necessary for a second CT scanner to be available to provide the best and timely care.

- Offer enhanced comfort.
- Meet growing community needs.

Heartfelt Holidays Participants Advance Cancer Care

Every year Madison Health Foundation and a community committee, organize Heartfelt Holidays, a holiday fundraising gala benefitting Madison Health's mission to provide exceptional care, close to home. Over 250 community members and business leaders joined together on December 1 to celebrate the hospital's advancements of the past year and bring the next year's hopes to fruition.

With breast cancer remaining one of the leading cancers in Madison County, according to the Ohio Department of Health, the Madison Health Foundation Board chose a project for Heartfelt Holidays that would improve accessibility for critical testing to diagnose and treat breast cancer. With this and the hospital's 2024 commitment to invest in a new MRI, it made sense for the Foundation to set a goal for Heartfelt Holidays to raise \$125,000 for the purchase of a breast coil component to add to this new MRI, to meet this critical testing need.

The evening included videos and appearances by an inspiring patient, Judy Wilson, and Madison Health Cancer Center providers: Dr. Brenda Sickles-Santanello, Dr. Ewa Mrozek, and Joel Rice, Certified Nurse Practitioner. Joel, a cancer survivor, and Madison Health Foundation Board Member working in medical oncology for nearly 20 years, shared that it means the world to patients and families to have cancer care and treatment close to home. "Currently patients in need of a breast MRI must travel outside of London, which turns into an entire day experience for them and their family. A breast coil at Madison Health would allow patients to see their providers, have needed testing to achieve their

diagnosis, and make plans for their treatment, all within the same facility, close to home."

Judy Wilson, a patient of the Madison Health Cancer Center part of the OSU James Cancer Network, expressed her gratitude for being able to receive care close to home, "I felt more independent being able to come ten minutes away for my treatment. I had to travel to Columbus to have my breast MRIs and didn't feel as independent as I did when I was getting my care at Madison Health. It took time to travel, and my family members had to take time away from work to go with me. Being so close to home means so much more. I would have loved to have my breast MRIs at Madison Health."

Through auctions, raffles, and a Call for the Cause, the attendees rallied behind Judy and patients in need of this critical MRI breast coil, to exceed the goal! Thanks to generous sponsors and attendees, \$148,000 was raised to make breast MRIs a reality for patients in our community.
